**ADDENDUM TO COSTS FOR PH.D. ABD STUDENTS:**

Based on the review of prior graduate transcripts and course descriptions, ABD students may transfer in a variable number of credits, resulting in the need to enroll in none, one, or two additional doctoral courses beyond 850 and 860 in their area of concentration, plus RMTH 900. This means that the total number of credits required for degree completion will be 9, 12, or 15, as courses in the program carry three credits.

**Tuition charges for ABD students have been reduced by a scholarship of \$354 per credit hour, bringing the per-credit charge down to \$800.** Tuition charges for each course in the program will be \$2,400. Tuition charges for the total program will range from \$7,200 to \$12,000, depending on whether 9, 12, or 15 credits are needed for completion. ABD students who do not complete their dissertation during enrollment in RMTH 900 must enroll in additional dissertation supervision, a non-credit-bearing course under the direction of the dissertation supervisor. The fee for this activity is typically \$4,950. ABD students may petition the Interim Academic Vice-President of the University to reduce the charge to \$2,400, consistent with the tuition charges for a three-credit course in the program, with the ABD scholarship.
